 Pursuant to Section 4 and Section 41 of the Commerce Commission Decree 2010 and the Commerce (Control of Prices for Ports Management Services) Order 2015, the Commission makes the following authorization for the Port fees and charges for Fiji Ports Corporation Limited and Fiji Ports Terminal Limited.

Citation and Commencement

2. This Authorization may be cited as Final Authorization on Ports Fees and Charges for Fiji Ports Corporation Limited and Fiji Ports Terminal Limited and is effective from 10 August 2015.

Maximum prices

- **3. (a)** The prices set out in Schedule 1 and Schedule 2 herein shall be the maximum rates applicable, as the case may be, at which the goods and services mentioned therein may be supplied as listed in Schedule 1 and Schedule 2.
 - (b) No new charges shall be levied unless authorized by the Commission.

 Sundays and public holidays are not included in the Free storage period. A free period of 24 hours is granted to bonded cargo land-bridged under bond to another port in Fiji.
